Non-Implementation of CJEU Rulings as a Constitutional Issue and an Issue of the Rule of Law

This panel will also examine key rulings of the Court of Justice of the EU concerning the rights of LGBTI+ people, and the systemic cases of their partial or complete lack of implementation by some Member States. It will seek answers to the question of what legal and policy instruments are in place to ensure the implementation of these rulings. This panel will focus on the CJEU cases: The European Commission v. Hungary, C-769/22, C-4/23 Mirin, C-247/23 Deldits, C-673/16, Coman C-490/20, V.M.A. v Stolichna obshtina, rayon "Pancharevo" and the last pending case C-43/24, Shipov in the context of the rule of law and the national and constitutional identity of the Member States.

Implementations of the ECtHR judgements

Bulgaria's implementation of European Court of Human Rights (ECtHR) judgments is characterized by a persistent backlog of cases, especially those requiring general measures, and a significant number of judgments under enhanced supervision by the Council of Europe's Committee of Ministers. LGBTI issues are small problem in the process of non-implementation naming the cases: Koilova and Babulkova v. Bulgaria (Application N: 40209/20) and P.H. v. Bulgaria (Application N: 46509/20)
